



# Notice of Race

## Keelboats, multihulls, trailer yachts and sport boats

The notation '[NP]' in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a).

### 1. Rules

- 1.1 The event is governed by the rules as defined in The Racing Rules of Sailing.
- 1.2 Safety regulations:
  - (a) The Yachting New Zealand Safety Regulations Part II Category 5 shall apply to keelboats and multihulls. Boats shall carry a serviceable inboard or outboard engine capable of driving the boat in smooth water at a speed exceeding 4 knots. The minimum amount of engine fuel to be carried upon leaving shore at the start of each day shall be  $LWL(m) / 0.4$ .
  - (b) The Yachting New Zealand Safety Regulations Part V Category A shall apply to trailer yachts. A minimum of five litres of fuel shall be carried upon leaving shore at the start of each day.
  - (c) The Yachting New Zealand Safety Regulations Part VI Category A shall apply to sports boats. A minimum of five litres of fuel shall be carried upon leaving shore at the start of each day.
  - (d) The Yachting New Zealand Safety Regulations Part 1 shall apply to E6 and E5.9 class boats.
- 1.3 The Yachting New Zealand "Rules – Performance Handicap Racing Fleet (PHRF) 2021-2024" will apply to boats racing under PHRF.
- 1.4 The Wellington Regional Council Navigation and Safety Bylaws, available at <http://www.gw.govt.nz> apply.
- 1.5 Safety checks of any boat may be made at any time.
- 1.6 The rules will be changed as follows.
  - (a) [NP] Boats with lifting keels shall have keels locked in the down position and not moved whilst racing. This changes RRS 51.
  - (b) Boats with movable ballast, in the form of a canting keel or water ballast, may move that ballast to increase or decrease weight, or to change trim or stability. This changes RRS 51.
  - (c) RRS 52 shall not apply to the adjustment of a canting keel or water ballast.
- 1.7 Appendix T, Arbitration will apply.

### 2. Sailing instructions

- 2.1 The sailing instructions will be available by 14 February 2022 at [www.portnicholsonregatta.org.nz](http://www.portnicholsonregatta.org.nz).



2.2 The sailing instructions will consist of the instructions in RRS Appendix S, Standard Sailing Instructions, and supplementary sailing instructions that will be on the official notice board located at [www.portnicholsonregatta.org.nz](http://www.portnicholsonregatta.org.nz).

**3. Communication**

3.1 The online official notice board is located at [www.portnicholsonregatta.org.nz](http://www.portnicholsonregatta.org.nz).

3.2 [DP][NP] All boats shall carry a VHF radio capable of communicating on channels 14, 16 and 62.

3.3 On the water, the race committee will make courtesy broadcasts to competitors on VHF radio. The channel will be stated in the SIs.

3.4 [DP][NP] While racing, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

**4. Eligibility and entry**

4.1 The regatta is open to all self-righting monohull boats, multi-hulls, trailer yachts, sports boats, E6 and E5.9 class boats.

4.2 Classes:

- (a) Sport boats
- (b) All other boats

4.3 Sports boats may be combined into one class with other boats if fewer than six sports boat entries are received.

4.4 The Organising Authority may split boats within a class into divisions.

4.5 The Organising Authority’s general handicap and Yachting New Zealand PHRF handicap shall apply.

4.6 Eligible boats may enter by completing the entry form and submitting it, together with the required fee at [www.portnicholsonregatta.org.nz](http://www.portnicholsonregatta.org.nz) by 1700 on 14 February 2022.

4.7 To be considered an entry in the event, a boat shall complete all registration requirements, provide a crew list and pay all fees.

4.8 Late boat entries may be accepted upon payment of the late entry fee, and at the Organising Authority’s sole discretion.

**5. Fees**

5.1 Entry fees are as follows:

Date of entry	Entry fee
Before 1 January 2021	\$295
From 1 January 2022 until 14 February 2022	\$310
Late entry fee	\$360

5.2 Entry fees will be refunded if the event is cancelled.

**6. Advertising**

6.1 [DP][NP] Boats may be required to display advertising chosen and supplied by the Organising Authority.



## **7. Schedule**

7.1 Registration: 1500-1830hrs on Thursday 17 February 2022.

7.2 Invitation race:

- (a) Date of race: 17 February 2022.
- (b) A briefing will be held at 1700 in the RPNYC Wardroom. A representative of each boat must attend.
- (c) The scheduled time for the warning signal is 1755.
- (d) This race will not be scored as part of the regatta series.

7.3 Regatta series:

- (a) Dates of racing: 18-20 February 2022.
- (b) There will be no briefing.
- (c) Number of races:
  - (i) Total number scheduled: 9
  - (ii) Races per day scheduled: 3
  - (iii) Races per day maximum: 4
- (d) The scheduled time of the warning signal for the first race each day is 1025.
- (e) On the last scheduled day of racing no warning signal will be made after 1455.

## **8. Equipment inspection**

8.1 Boats may be inspected at any time.

## **9. Venue**

9.1 The event will be held at the Royal Port Nicholson Yacht Club, 103 Oriental Parade, Wellington.

9.2 All races will be held within Wellington Harbour as marked on chart NZ4633.

## **10. Courses**

10.1 Windward-leeward, triangle and harbour courses may be sailed.

## **12. Scoring**

12.1 One race is required to be completed to constitute a series.

12.2 When fewer than five races have been completed, a boat's series score will be the total of her race scores.

12.3 When from five or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

## **13. Support person vessels**

13.1 Lim[DP][NP] All support person vessels shall always have an engine safety cut out switch (kill cord) attached to the driver while the engine is running, unless prior written exemption has been provided by the Organising Authority.



#### 14. Risk statement

- 14.1 RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' By participating in this event each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform and fatigue resulting in increased risk of injury. **Inherent in the sport of sailing is the risk of permanent, catastrophic injury or death by drowning, trauma, hypothermia or other causes.**

#### 15. Insurance

- 15.1 [DP][NP] Each participating boat shall be insured with valid third-party liability insurance with minimum cover of \$5,000,000 per incident or the equivalent. A certificate of insurance is to be provided if required by the Organising Authority.

#### 16. Prizes

- 16.1 The Ross Telford Memorial Trophy will be awarded to the 2022 Port Nicholson Regatta Champion. The regatta champion will be determined by the Organising Authority.
